**RELEASE AND DISCHARGE  
OF SECURITY INTEREST (INTELLECTUAL PROPERTY)**

WHEREAS, The Bank of Nova Scotia (the “**Secured Party**”) and Geroline Inc. (“**Geroline**”) entered into a security agreement dated February 15, 2019 (the “**Security Agreement**”) with respect to the intellectual property of Geroline;

AND WHEREAS the Security Agreement was placed on file with the United States Patent and Trademarks Office (the “**USPTO**”) on or about February 20, 2019 (Reel/Frame: 048369/0603 and Reel/Frame: 6566/0746), pursuant to which a security interest was granted in favour of the Secured Party in and to the trademarks, trademark applications and design patents set out in “Schedule A” (the “**US Trademarks and Designs**”);

AND WHEREAS the Security Agreement was placed on file in the Canadian Intellectual Property Office (the “**CIPO**”) on or about March 15, 2019, pursuant to which a security interest was granted in favour of the Secured Party in and to the trademarks, trademark applications and industrial designs set out in “Schedule B” (the “**Canadian Trademarks and Designs**”, together with the US Trademarks and Designs, the “**Intellectual Property**”);

AND WHEREAS the Secured Party wishes to release all of its interest in and to the Intellectual Property from the records of the CIPO and the USPTO;

NOW THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and adequacy of which are acknowledged, the Secured Party:

1. confirms that it has not assigned or otherwise disposed of its interest in and to the Intellectual Property;
2. hereby relinquishes, releases and terminates all of its rights, title and interest in and to the Intellectual Property and grants a full and final discharge of same;
3. hereby directs the Commissioner of Trademarks and the USPTO to record this Release and Discharge of Security Interest, in such places as he or she deems necessary of advisable to give effect hereto; and
4. hereby releases and discharges its full interest in and to the Intellectual Property.
