Under Section 242 of the Delaware General Corporation Law ("DGCL"),

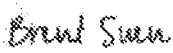
IT IS HEREBY CERTIFIED THAT:

4. Pursuant to Section 141(f) of the DGCL, this Certificate was authorized by the unanimous written consent of the board of directors of the Corporation on July 31, 2020, and absent stockholder approval pursuant to Section 242(b)(1) of the DGCL.
