**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 23rd day of October, 2020, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, in its capacity as collateral agent (“Agent”), in favor of SUTHERLAND GLOBAL SERVICES INC. (“SGS”) and SUTHERLAND HEALTHCARE SOLUTIONS INC. (“SHS”, and together with SGS, the “Grantors”, and each, a “Grantor”).

WHEREAS, SGS entered into (i) that certain Trademark Security Agreement, dated October 23, 2014, with Bank of America, N.A., in its capacity as collateral agent (“Bank of America”), notice of which was recorded with the United States Patent and Trademark Office (“USPTO”) on October 24, 2014 at reel/frame 5387/0394 (the “2014 SGS Trademark Security Agreement”) and the corresponding Trademark Security Interest Assignment Agreement, dated August 16, 2017, with Agent and Bank of America, notice of which was recorded with the USPTO on August 16, 2017 at reel/frame 6135/0291 (the “SGS Trademark Security Interest Assignment”), and (ii) that certain Trademark Security Agreement, dated August 16, 2017, with Agent, notice of which was recorded with the USPTO on August 16, 2017 at reel/frame 6131/0134 (the “2017 SGS Trademark Security Agreement”, and together with the 2014 SGS Trademark Security Agreement and the SGS Trademark Security Interest Assignment, the “SGS Agreements”).

WHEREAS, SHS entered into that certain Trademark Security Agreement, dated October 23, 2014, with Bank of America, notice of which was recorded with the USPTO on October 24, 2014 at reel/frame 5387/0354 (the “SHS Trademark Security Agreement”) and the corresponding Trademark Security Interest Assignment Agreement, dated August 16, 2017, with Agent and Bank of America, notice of which was recorded with the USPTO on August 16, 2017 at reel/frame 6133/0677 (the “SHS Trademark Security Interest Assignment”, and together with

the SGS Agreements and the SHS Trademark Security Agreement, the “Trademark Security Agreements”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the applicable Trademark Security Agreement.

WHEREAS, Grantors granted or assigned, as applicable, to Agent, under the terms of the Trademark Security Agreements, a security interest in favor of Agent, in and to all of their right, title and interest in and to the trademark collateral, including without limitation the trademarks listed in Schedule I (the “Trademarks”).

WHEREAS, Agent has agreed to terminate and release its security interest in all such trademark collateral, including without limitation such Trademarks, as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in the trademark collateral, including without limitation, the rights, title and interest in, to and under the Trademarks listed on Schedule I attached hereto and made a part hereof, all proceeds and products of the Trademarks, the goodwill of the businesses with which the Trademarks are associated, and all causes of action for infringement of the Trademarks or unfair competition regarding the same, and hereby assigns, transfers and conveys to Grantor any and all interest in all of the foregoing, including the security interest.
