## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of October 26, 2020 (this “**Trademark Release**”) is executed and delivered by Bank of America, N.A., as Agent (the “**Agent**”), under the Notice of Grant of Security Interest in Trademarks, dated as of April 24, 2019 (the “**Trademark Grant**”), made by Rent the Runway, Inc. (the “**Grantor**”) in favor of the Agent and recorded April 26, 2019 in the records of the United States Patent and Trademark Office at Trademark Reel 6629, Frame 0938.

WHEREAS, the Grantor has entered into that certain Security Agreement, dated as of April 24, 2019 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “**Security Agreement**”), by and among the Grantor, the other entities from time to time party thereto and the Agent, in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Agent a continuing security interest in all right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined in the Trademark Grant);

WHEREAS, the Agent now wishes to release and terminate its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Unless otherwise defined herein, any capitalized term used herein shall have the meaning given to it in the Trademark Grant.


2. The Agent hereby (i) terminates and cancels the Trademark Grant, (ii) terminates, cancels, releases and discharges all of its security interest in all of the Grantor’s right, title and interest in and to the Trademark Collateral and (iii) reassigns and reconveys to the Grantor all right, title and interest of the Agent in the Trademark Collateral, including, without limitation, the trademarks and trademark applications listed on Schedule I attached hereto, including the good-will of the business symbolized thereby and all rights to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof and all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto.

3. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents as may be reasonably necessary to effect, record or evidence more fully the purposes of this Trademark Release.

4. The Agent authorizes and requests that the Commissioner of Trademarks of the United States Patent and Trademark Office record this Trademark Release.
