Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:


**FIRST:** Article 1 of the Amended and Restated Articles of Incorporation of Norman Love Confections, Inc. is amended to read as follows:
