TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT is entered into as of the last date of signature below by and between ADAM KOLOM ("*Assignor*"), an individual, and BAREFOOT SCIENCES, INC. NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignor hereby irrevocably assigns, transfers, conveys and delivers to the Assignee all rights, title, and interest, in the United States and throughout the world, in and to the Trademarks and all goodwill associated therewith, together with that portion of the ongoing and existing business in connection with which the Assignor has a bona fide intent to use the Trademarks, and all rights appurtenant thereto, including, all common law rights, all causes of action, and all claims for damages, profits and other awards by reason of past infringement, dilution, misappropriation or other violations thereof, including the right to sue therefor.

2. From time to time after the date hereof, and for no further consideration, Assignor and Assignee shall execute, acknowledge and deliver such assignments, transfers, consents, assumptions and other documents and instruments and take such other actions as may reasonably be necessary to consummate the transactions contemplated hereby. Assignor shall ensure that copies of all correspondence in relation to the Trademarks that it, or its agents, receive (including any renewal advice or other notification received from any government agency) are promptly delivered to Assignee.

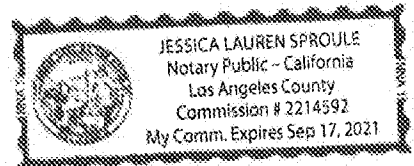
