Pursuant to the provisions of Section 48-249-702 of the Tennessee Revised Limited Liability Company Act and Section 48-21-107 of the Tennessee Business Corporation Act, the undersigned hereby submits these Articles of Merger and states as follows:

1. The constituent parties to the merger are Expression Health Analytics, LLC, a Tennessee limited liability company (the "Merging LLC"), and Aegis Health Group, Inc., a Tennessee corporation (the "Surviving Corporation"). Upon the filing of these Articles of Merger with the Secretary of State of Tennessee, the Merging LLC shall merge with and into the Surviving Corporation, after which the Surviving Corporation shall survive and the Merging LLC shall cease to exist (the "Merger").

2. No amendments to the charter of the Surviving Corporation are effected by the merger.

3. Approval of the Agreement and Plan of Merger (the "Plan of Merger") by the shareholders of the Surviving Corporation is not required by the Tennessee Business Corporation Act. The Plan of Merger was approved and adopted by the Board of Directors of the Surviving Corporation on October 24, 2018.

4. On October 24, 2018, the Plan of Merger and the performance of its terms were duly authorized and approved by all actions required by the laws of the jurisdiction of organization of the Merging LLC and by its organic documents.

5. The Plan of Merger has been executed by the Merging LLC and the Surviving Corporation and is on file at the place of business of the Surviving Corporation located at 8 Cadillac Drive, Suite 450 Brentwood, Tennessee 37027.

6. A copy of the Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any person holding an interest in the Surviving Corporation or to any person holding an interest in the Merging LLC.
