TRADEMARK ASSIGNMENT

WHEREAS this Trademark Assignment ("Assignment") is made and entered into effective this 8th day of October 2020 (the "Effective Date");

WHEREAS, Klee Data System, a société par actions simplifiée of France, ("ASSIGNOR"), of 11 Chemin de Bretagne, Issy les Moulineaux, France, owns certain registered and common law rights in the trademarks KDS, KDS NEO, NEO, and trademarks having designs incorporating some or all of the foregoing, including related goodwill ("the Trademarks") listed in Exhibit A hereto;


WHEREAS, GBT TRAVEL SERVICES UK LIMITED, located at 5 Churchill Place, Canary Wharf, London ENGLAND E145HU ("ASSIGNEE"), a UK limited company, desires to acquire the Trademarks;

WHEREAS, ASSIGNOR desires to assign, convey and transfer the Trademarks to ASSIGNEE;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. **Assignment of Trademarks.** ASSIGNOR does hereby assign, convey and transfer to ASSIGNEE, its successors and assigns, ASSIGNOR's entire rights, title and interest in and to the Trademarks along with the related goodwill of the business represented by the Trademarks, in all countries or jurisdictions, including all registered and common law rights thereto, and including rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) sue for past, present and future infringement and to collect damages therefor, and (c) grant licenses or other interests to and in the Trademarks.
- 2. **Successors and Assigns.** This Agreement shall bind and inure to the benefit of the Parties and their respective successors and assigns.
- 3. **Counterparts.** This agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same instrument.

IN WITNESS WHEREOF, the Parties have caused this Agreement to be duly executed as of the Effective Date.
