RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 26th day of October 2020, by GLAS Trust Corporation Limited, in its capacity as security agent and trustee (the “Security Agent”) for the Beneficiaries (as defined in that certain Debenture dated as of April 4, 2018 among the Grantor, the other grantors named therein from time to time, and the Security Agent), in favor of BigHand Limited (the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of July 3, 2018 made by the Grantor in favor of the Security Agent (the “Security Agreement”), a security interest was granted by the Grantor to the Security Agent in the Trademark Collateral (as defined in the Security Agreement), including the United States trademarks set forth in Schedule A hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2018 at Reel/Frame 6372/0905;

WHEREAS, the Security Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in all Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Agent hereby states as follows::

1. Release of Security Interest. The Security Agent, on its and the Beneficiaries’ behalf, hereby terminates the Security Agreement and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges the collateral pledges, grants, liens and security interests granted by the Grantor in favor of the Security Agent (on behalf of itself, the Beneficiaries and their permitted successors and assigns) in and to the Trademark Collateral and all rights, title and interests in, to and under the Trademark Collateral.

3. Recordation of Release. The Security Agent understands and agrees that this Release may be recorded by the Grantor, or its successors or assigns, with the United States Patent and Trademark Office.

4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.


