**SERVICE MARK ASSIGNMENT**

**THIS SERVICE MARK ASSIGNMENT** (“Assignment”), effective as of November 1, 2020 (“Effective Date”), is made and entered into by Commercial Partners Title, LLC, a Minnesota limited liability company (“Assignor”), in favor of Chicago Title Company, LLC, a Delaware limited liability company (“Assignee”).


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
