**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST IN CERTAIN
TRADEMARKS**

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST IN CERTAIN TRADEMARKS** ("Release") is made and effective as of May 7, 2020 and granted by NFS Leasing, Inc., a Massachusetts corporation, as the Secured Party (the "**Secured Party**"), in favor of Veritas Genetics, Inc., a Delaware corporation (the "**Company**") (the "**Grantor**") and their successors, assigns and legal representatives. Capitalized terms used and not otherwise defined in this Release shall have the meanings assigned to them in the Security Agreement (defined below).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of February 13, 2020 (the "**Security Agreement**"), among the Grantor, the Secured Party, the Grantor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to and under the Collateral (as defined below); and

WHEREAS, the Grantor has requested that the Secured Party enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Secured Party may have in the Collateral (as defined below) pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby states as follows:

1. **Release of Security Interest in Certain Trademarks**. The Secured Party, on behalf of itself and successors, legal representatives and assigns, terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in the Collateral (as defined below), and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under only the following (collectively, the "**Collateral**"):
 - (a) the trademarks described in Schedule A attached hereto, including the trademark registrations pertaining thereto and as may be described in Schedule A, together with the goodwill of the business in connection with which the Trademarks have been (the "**Trademarks**");
 - (b) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse, or breach with respect to the Trademarks, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
 - (c) any and all proceeds of the foregoing, for income, royalties, and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the foregoing or arising from any of the foregoing.
2. **Security Agreement Remains in Effect**. The Security Agreement remains in full force and effect except for the Release granted herein. Secured Party retains its continuing security interest in the Collateral (defined in the Security Agreement) other than the Collateral (as defined herein) which is now being released.

3. Entire Agreement. This Release represents the final agreement among the parties and may not be contradicted by evidence of prior, contemporaneous or subsequent oral agreements of the parties or by prior or contemporaneous written agreements.

4. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Massachusetts.
