TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNEE desires to acquire all rights, title, and interest in and to the Trademarks and Applications worldwide and any other registered or unregistered Trademarks owned or used by ASSIGNOR or any of its licensees or predecessors in interest worldwide, together with the goodwill, which is ongoing and existing, symbolized by said Trademarks; and

WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks and Applications, worldwide and any other registered or unregistered Trademarks owned or used by ASSIGNOR or any of its licensees worldwide, together with the goodwill, which is ongoing and existing, symbolized by said Trademarks.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR and ASSIGNEE agree as follows:


ASSIGNOR hereby assigns and transfers to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:


