THIS AGREEMENT is made the 9th day of October 2020

BETWEEN:

- (1) **THE WEST RETAIL GROUP LIMITED** incorporated and registered in England and Wales with company number 05050619 whose address is Manor Farm, Main Street, Hotham York, East Yorkshire YO43 4UD (**Assignor**);
- (2) **WREN US HOLDINGS LIMITED** incorporated and registered in England and Wales with company number 12110768 whose address is at The Nest, Falkland Way, Barton on Humber, DN18 5RL (**Assignee**).

BACKGROUND:

- (A) The Assignor is the registered proprietor of the trade mark, particulars of which are set out in Schedule 1 (**Trade Mark**).
- (B) The Assignor has agreed to assign the Trade Mark to the Assignee on the terms set out in this assignment.

It is hereby agreed

1. Assignment

1.1 In consideration of the mutual agreements contained herein and for and in consideration of £1 and other good and valuable consideration, acknowledged by Assignor and Assignee to be satisfactory, adequate, and received, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all right, title and interest in and to the Trade Mark including:

- (a) all statutory and common law rights attaching to the Trade Mark, together with any trade dress associated therewith and the goodwill of the business relating to the goods or services in respect of which the Trade Mark is registered or used; and
- (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of the Trade Mark whether occurring before, on or after the date of this assignment.

2. Further Assurance

2.1 The Assignor shall, at its own cost, perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution or delivery of) all further documents, required by law or which the Assignee requests to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this Assignment, including registration of the Assignee as applicant or registered proprietor of the Trade Mark.

2.2 The Assignor shall do the following at the Assignee's cost and direction, pending formal registration or recordal of the assignment of the Trade Mark to the Assignee:

- (a) if legally required to do so, pay all applicable application, filing, registration, renewal and other fees as they fall due;
- (b) if legally required to do so, promptly satisfy all official actions issued by any relevant trade mark registry or authority;
- (c) provide the Assignee with all information and other assistance required to enable the Assignee to prepare, file or prosecute applications for registration of the Trade Mark (including producing, in the appropriate form, any evidence of its use of the Trade Mark);

- (d) provide the Assignee with all information and other assistance required by the Assignee to conduct, defend or settle any relevant claims, actions or proceedings (including, if requested by the Assignee, bringing proceedings in its own name or lending its name to the proceedings brought by the Assignee).

3. Counterparts


- 3.1 This agreement may be executed in any number of duplicate counterparts, each of which when executed and delivered (by hand-delivery, mail, fax, or email) shall constitute an original of this agreement, but all the counterparts shall together constitute the same agreement.

4. Governing law and jurisdiction

- 4.1 This assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.
- 4.2 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this assignment or its subject matter or formation (including non-contractual disputes or claims).

This agreement takes effect on the date stated at the beginning of it.
