RELEASE OF SECURITY INTEREST IN INTELLECUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of October 29, 2020, by CANADIAN IMPERIAL BANK OF COMMERCE (“**Bank**”) in favor of CALYTERA US, INC., a Delaware corporation (“**Calytera US**”), CALYTERA SOFTWARE, INC., a British Columbia corporation (“**Calytera Canada**”) and CALYTERA, INC., a Delaware corporation (“**Parent**” and, together with Calytera US and Parent, each a “Grantor” and collectively, “**Grantors**”) with its principal place of business located at 804 Las Cimas Parkway, Suite 100, Austin, TX 78704.

Recital

WHEREAS, Grantors granted to Bank a security interest in the copyrights and trademarks described on Exhibits A and B attached hereto (the “**Intellectual Property**”) under an Intellectual Property Security Agreement dated as of January 3, 2020 (the “**IP Security Agreement**”), which was submitted for recordation with the Library of Congress Copyright Office on January 3, 2020, and recorded with the U.S. Patent and Trademark Office as set forth on Exhibit B.

WHEREAS, Grantors have requested and Bank has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.

Agreement

Now, therefore, Bank agrees that it discharges, terminates and releases its security interest, including all rights, title and interest in, to, and under the Intellectual Property, terminates the IP Security Agreement, and hereby reassigns, transfers and conveys to Grantors, without warranty or recourse, all interest of Bank in the Intellectual Property, including the security interest.
