IT IS HEREBY CERTIFIED THAT:

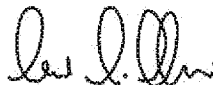
FIRST: The name of the LLC, prior to the time that this Certificate of Amendment takes effect, is R. Smith International, L.L.C.
