RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

All of Lender’s security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created in Borrower’s Intellectual Property pursuant to the Security Agreement shall be automatically terminated, released and discharged.

If and to the extent that Lender has acquired any right, title or interest in or to any of the Borrower’s Intellectual Property, it hereby assigns and transfers such rights, title or interest to Borrower, along with any goodwill in the Intellectual Property that Lender may have acquired.
