CONFIRMATORY TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), dated as of November 3, 2020 (the "Effective Date"), is by and among Lantos Technologies, Inc., a Delaware corporation located at c/o Verdolino & Lowey, P.C., 124 Washington Street, Suite 101, Foxboro, MA 02035 ("Assignor"), and Lantos 2.0, Inc., a Delaware corporation located at 34 Rte. 111, Suite 101, Derry, NH 03038 ("Assignee").

WHEREAS, the Assignor and Assignee are parties to a Secured Party Bill of Sale and Transfer Statement ("Bill of Sale") dated as of the Effective Date;

WHEREAS, the Bill of Sale transfers, assigns and conveys to Assignee, its successors and assigns all right, title and interest of Assignor in the trademarks and applications and registrations therefore listed in the attached Schedule A, together with the goodwill associated therewith (the "Marks"); and

WHEREAS, Assignor and Assignee wish to confirm the assignment of such Marks and record the assignment at the US Patent and Trademark Office, Canadian Intellectual Property Office and other intellectual property offices.

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency, and adequacy of which are hereby acknowledged, Assignor hereby confirms as follows:

1. Assignment. As of the Effective Date, and under and subject to the terms and conditions of the Bill of Sale, Assignor hereby confirms that all of its right, title and interest, throughout the world, in and to the Marks (including any common law rights that may exist and are associated therewith) has been assigned, transferred, conveyed and delivered unto Assignee, and to the extent that such assignment did not occur, Assignor does hereby assign, transfer, convey and deliver, all of its right, title and interest, throughout the world, in and to the Marks (including any common law rights that may exist and are associated therewith), together with: (i) all registrations and applications for registration of the Marks, including without limitation those identified on the attached Schedule A; (ii) the goodwill of the business symbolized by and associated with the Marks, the same to be held and enjoyed by Assignee, its successors, and assigns; and (iii) all rights to all past, present and future claims for infringement or dilution of, or damage or injury to, the Marks including without limitation the right to grant licenses, to bring lawsuits or administrative actions, and to recover damages and profits for any past, present, and future infringement, whether known or unknown, now existing or hereafter arising. Assignor consents to the recordation of this Assignment with any governmental agency. Assignor acknowledges that, subsequent to the date hereof, Assignor shall not claim to possess any right, title or interest in and to such Marks.
2. Further Assurances. Assignor agrees to provide such reasonable assistance to Assignee, at Assignee's cost, as required by and subject in all respects to, the Bill of Sale and that certain Post Closing Matters Agreement, dated as of the Effective Date, between the Assignor and Assignee. In the event Assignor is unavailable, unable, unwilling or otherwise does not promptly (within two business days), cooperate with Assignee's request to execute additional documents that may be necessary to record and perfect this Assignment in a timely way,

including but not limited to additional assignment documents that may be necessary to meet country-specific requirements ("Additional Assignment Documents"). Assignor hereby irrevocably grants to Assignee the necessary authorization and power of attorney to execute and deliver such Additional Assignment Documents on its behalf and in its name and to do all other lawfully permitted acts to record ownership of the Marks in the name of Assignee or its designee, and to transfer, record and perfect the assignment of the Marks to Assignee or its designee (without limiting the rights Assignee shall have in such circumstances by operation of law). This power of attorney is coupled with an interest, irrevocable and shall not be impacted by the Assignor's insolvency or dissolution.

3. Counterparts and Facsimile or .pdf Signature. This Assignment may be executed in two or more counterparts, all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party. This Assignment may be executed by facsimile or .pdf signature and a facsimile or .pdf signature shall constitute an original for all purposes.
4. Headings. The headings contained in this Assignment or in any Schedule are for convenience of reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.
5. Successors. This Assignment shall be binding upon, inure to the benefit of, and be enforceable by, the parties hereto and their respective successors and permitted assigns.
