**TERMINATION AND RELEASE OF  
SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Second Lien Intellectual Property Security Agreement (“Release”) is made as of November 25, 2020, by **TRUIST BANK** (successor by merger to SunTrust Bank) a North Carolina banking corporation (“Administrative Agent”) in favor of **HIGGINBOTHAM INSURANCE AGENCY, INC.**, a Texas corporation with an address at 500 West 13<sup>th</sup> Street, Fort Worth, Texas 76102 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain second lien intellectual property security agreement dated December 19, 2017 (the “IP Security Agreement”) with Administrative Agent, notice of which was recorded on December 19, 2017 at the United States Patent and Trademark Office at Reel 6234, Frame 0052.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the IP Security Agreement, a security interest (the “Security Interest”) in favor of the Administrative Agent, in all of its right, title and interest in and to the Collateral, including the Trademarks listed in Schedule A, including the goodwill symbolized thereby.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Collateral of the Grantor, including and all of the goodwill symbolized thereby, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
