## TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (the “Release”) is made as of November 23, 2020 (the “Release Date”) by PENNANTPARK INVESTMENT ADMINISTRATION, LLC, as an administrative agent (the “First Lien Agent”), for the benefit of CANO HEALTH, LLC, a Florida limited liability company (the “Debtor”).

WHEREAS, the Debtor entered into that certain Amended and Restated Intellectual Property Security Agreement, dated as of June 1, 2020 with the First Lien Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Security Agreement”), pursuant to which Debtor has granted to the First Lien Agent a continuing security interest in all of such Debtor's right, title and interest in and to, whether now owned or hereafter acquired or arising, certain Collateral, including the registered trademarks and pending applications for registration of trademarks listed on **Schedule 1** hereto (collectively, the “Trademarks”);

WHEREAS, on June 1, 2020, the First Lien Agent recorded with the United States Patent and Trademark Office (the “USPTO”), at Reel 006949, Frame 0692, notices of security interests in the Trademarks; and

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreement have been satisfied and the Debtor has requested that the First Lien Agent release their security interest in the Trademarks.


NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the First Lien Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the First Lien Agent hereby irrevocably and forever terminates the Security Agreement and terminates, releases and discharges the entirety of the security interest and continuing lien on the Trademarks.
2. Recordation of Release. The First Lien Agent understands and agrees that this Release may be recorded by or for the Debtor with the USPTO at the Debtor's sole cost and expense.
3. Further Actions. The First Lien Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtor may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Debtor and the cost and expense of such documents and actions shall be borne solely by the Debtor.
4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement, as applicable.
