ASSIGNMENT OF TRADEMARKS

- (2) All said right, title and interest to the Trademarks shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment of Trademarks had not been made.

(3) The assignee is a successor to the original applicant's business, or portion of the business to which the mark pertains.

(4) The effective date of this Assignment of Trademark is November 25, 2020.
