**SECOND:** The jurisdiction immediately prior to filing this Certificate of Conversion is California.

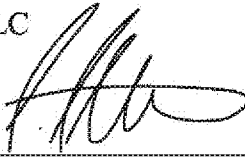
**THIRD:** The date the Company was first formed in California is September 16, 2008 in the name of Orgain, Inc.
