**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of November 19, 2020 by **JPMORGAN CHASE BANK, N.A.**, a United States national banking association (“Administrative Agent”) in favor of **SILVER CREEK OIL & GAS, LLC**, a Delaware limited liability company, **SILVER CREEK MANAGEMENT HOLDINGS, INC.**, a Delaware corporation, and **SILVER CREEK MANAGEMENT, LLC**, a Delaware limited liability company (each, a “Grantor”, and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into that certain Amended and Restated Trademark Security Agreement dated as of June 16, 2017 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on June 19, 2017 at the United States Patent and Trademark Office at Reel 6105, Frame 0632.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent in and to all the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Secured Parties, hereby releases, terminates and discharges any and all of its interest (including the Security Interest and any other liens) in the Trademark Collateral of the Grantors, including all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and assigns, transfers and conveys to Grantors any interest in such intellectual property.
