RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, WEALTHENGINE, INC., a Delaware corporation (“**Grantor**”), and CANADIAN IMPERIAL BANK OF COMMERCE, a Canadian national bank (“**Lender**”), entered into an Intellectual Property Security Agreement dated as of January 3, 2019 (the “Security Agreement”), pursuant to which the Grantor pledged to Lender a security interest in certain intellectual property assets of Grantor;

WHEREAS, a true and correct copy of the Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on January 9, 2019, at Reel 6520, Frame 0519, against the trademarks and corresponding registrations listed on Exhibit A attached hereto (the “Trademarks”);


WHEREAS, the parties desire to confirm the release of all security interests which had been granted in favor of Lender in the Trademarks; and

WHEREAS, Grantor has requested and Lender has agreed to provide a document suitable for filing with the USPTO for purposes of recording the release of Lender’s security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby releases, relinquishes and discharges its security interest and all other rights in the Trademarks that Lender has, had, or could have had pursuant to the Security Agreement. Lender hereby further authorizes the Grantor to take any and all actions, including filing and recording this Release document with the appropriate governmental authorities to effectuate and further document the release made hereby.


