

RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**") is made and effective as of December 11, 2020 and granted by GBG USA Inc., a Delaware corporation ("**Lender**"), as lender under the Amended and Restated Convertible Promissory Note, dated July 29, 2016, by Rachel Zoe Creations, LLC, a Delaware limited liability company ("**RZC**"), and payable to Lender for the aggregate principal amount of \$9,000,000 (the "**Note**").

WHEREAS, pursuant to the Note, the Lender and RZC entered into (i) that certain Security Agreement, dated July 29, 2016 (the "Master Security Agreement") and (ii) that certain Trademark Security Agreement, dated July 29, 2016 (the "Trademark Security Agreement" and, together with the Master Security Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, RZC pledged and granted to Lender for the benefit of Lender a security interest in and to all of the right, title and interest of RZC in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5859, Frame 0516 on August 19, 2016; and

WHEREAS, the RZC has requested that Lender enter into this Release in order to effectuate, evidence and record the release and reassignment to RZC of any and all right, title and interest the Lender may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

- 1. Release of Security Interest. Lender, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of RZC, and reassigns to RZC any and all right, title and interest that it may have, in, to and under the following (collectively, the "Trademark Collateral"):
 - (a) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof ("**Trademarks**");
 - (b) all rights of any kind whatsoever of RZC accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
 - (c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
 - (d) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to

and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

- 2. <u>Further Assurances</u>. Lender agrees to take all further actions, and provide to the RZC and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as RZC and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
- 3. <u>Governing Law.</u> This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
