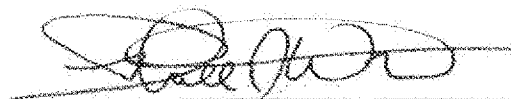
RESOLVED, that Article FIRST of the Certificate of Incorporation of the Corporation be amended to read as follows:
