## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Agreement”) dated as of December 11, 2020, from BMO HARRIS BANK, N.A., as collateral agent (“Agent”), to VINCIT COMPANY, LLC (the “Grantor”).

### **WITNESSETH:**

WHEREAS, pursuant to that certain Credit Agreement, dated as of December 1, 2011 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Grantor and Agent, the Grantor agreed to the payment and performance of its Obligations upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to that certain General Security Agreement by and between the Grantor and Agent dated as of December 1, 2011 in favor of the Agent (the “Security Agreement”), the Grantor granted a security interest to the Agent in the trademarks listed on Schedule 1 attached hereto (the “Trademark Collateral”);

WHEREAS, a Confirmatory Assignment of Security Interests in Patents, Trademarks, and Copyrights dated December 1, 2011 was recorded in the Trademark Division of the United States Patent and Trademark Office on January 12, 2012 at Reel 004697, Frame 0363;

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Agent hereby agrees and acknowledges as follows:

1. Definitions. Unless otherwise defined herein, terms used in this Agreement have the meanings provided in the Credit Agreement and the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral, including those listed on Schedule 1 attached hereto and made a part hereof, and assigns to the Grantor, without recourse, all of the Agent’s right, title and interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and be void. Agent understands and agrees that this Agreement may be recorded by or for the Grantor, with the United States Patent and Trademark Office or any similar office or agency.


3. Further Assurances. Upon request by the Grantor, the Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the security interest contemplated hereby.

4. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Illinois (without giving effect to conflict of law rules).
