## THE TRADEMARK ASSIGNMENT

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:



Assignor does hereby authorize the Secretary of State of the State of California to record the RP Studios Mark and title thereto as the property of Assignee, its successors, assigns or legal representatives in accordance with the terms of this instrument.

To the extent Assignor retains any rights, title or interest in or to the Service Marks that cannot be assigned to Assignee pursuant to this Agreement, Assignor hereby agrees to not waive any claims against Assignor may have in the Service Marks.
