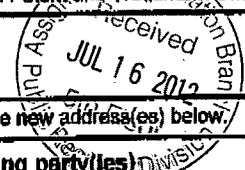

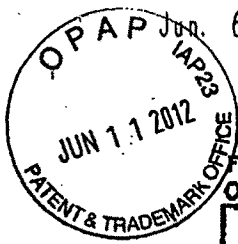

WHEREAS, CM Liquidation, Inc. (formerly known as Carlon Meter Company, Inc.), a Michigan corporation, of 1710 Eaton Drive, Grand Haven, Michigan 49417, (hereinafter "Assignor"), has adopted, used and is using the trademark "Carlon," which is the subject of United States Registration No. 2717301, registered on May 20, 2003;

WHEREAS Assignor has also adopted, used and is using the trademark "Carlon Meter," which is the subject of United States Registration No. 2717302, registered on May 20, 2003. "Carlon" and "Carlon Meter" are together known as the "Marks."
