**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of December 30, 2020, is made by **JPMORGAN CHASE BANK, N.A.**, (the "Grantee"), as the lender under the Credit Agreement referred to below, in favor of **INSPIRED BEAUTY BRANDS, INC.** (the "Grantor"). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Trademark Security Agreement or the Security Agreement (in each case, as hereinafter defined), as applicable.

WHEREAS, in connection with that certain Credit Agreement dated as of January 26, 2017 (as amended, restated, supplemented, extended, refinanced or otherwise modified from time to time, the "Credit Agreement"), among the Grantor, certain Subsidiaries of the Grantor, and the Grantee, the Grantee had agreed to make loans and extend other financial accommodations to or for the benefit of the Grantor;

WHEREAS, the Grantor and certain Subsidiaries of the Grantor entered into that certain Pledge and Security Agreement dated as of January 26, 2017 (as amended, restated, supplemented or otherwise modified, the "Security Agreement"),

WHEREAS, in connection with the Credit Agreement and pursuant to the Security Agreement, the Grantor granted security interests in certain intellectual property owned by Grantor, including those Trademarks listed on Annex I attached hereto, and Grantor reaffirmed its intent to grant such security interest in such trademarks pursuant to that certain Trademark Security Agreement dated as of May 11, 2018, by Grantor in favor of Grantee (the "Trademark Security Agreement"); and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office, on May 11, 2018 at Reel/Frame 6329/0663.

NOW THEREFORE for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including the entirety of its lien on and security interest in, and right of setoff against, the trademarks, whether granted pursuant to the Security Agreement or any other agreement or document delivered in connection with the Credit Agreement, and the Grantee hereby reassigns any and all such right, title and interest (if any) that the Grantee may have in, to and under the trademarks to Grantor.

The Grantee agrees, at Grantor's expense, to cooperate with Grantor and to provide Grantor with the information and additional authorization, including by executing any further instruments, reasonably required or desirable to effect the release of the Grantee's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
