ASSIGNMENT

WHEREAS, Richard Etrheim, an unmarried individual, formerly of 2216 Shadywood, Orono, Minnesota 55391, now residing at 1300 North Lakeshore Drive, Chicago, IL 60610 (hereinafter referred to as "Etrheim") is the sole owner of the mark: REAL PEANUT BUTTER, Registration No. 5,377,100, Registered January 9, 2018, Int. Cl.: 29: Peanut Butter, copy of USPTO Certificate attached as Exhibit A (hereafter referred to as the "Mark").

WHEREAS, Market Distribution, Inc., d/b/a Market Distributing, a Minnesota corporation (hereinafter referred to as "Market Distributing") and Etrheim entered into an Intellectual Property Assignment Agreement and Bill of Sale dated December 24, 2020 under which Etrheim agreed to assign, transfer and convey to Market Distributing all of Etrheim's right, title and interest in and to the mark and as listed in Exhibit A together with any and all U.S. registrations and applications for registration of such mark, any copyrightable subject matter in such mark that is protected or eligible for protection by a U.S. copyright registration, and the goodwill of the business associated with such mark;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Etrheim, Etrheim does hereby sell, assign and transfer and set over to Market Distributing the entire right, title and interest in and to (a) the mark, applications and registrations identified in Exhibit A together with the goodwill of the business associated with the mark, and (b) any copyrightable subject matter in the said mark that is protected or eligible for protection by a U.S. copyright registration.

Etrheim agrees that he will not hereafter adopt or use any mark or name confusingly similar to the mark listed in Exhibit A, or which tends to dilute its distinctiveness.

Etrheim further agrees that it will not contest Market Distributing's ownership


of the mark or marks if in the future similar applications are sought, registrations, applications for registration, goodwill or copyrights assigned, including in any claim, action, arbitration, suit, inquiry or proceeding.

Ertheim further agrees that he will take such further actions, make all rightful oaths and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the mark(s), registrations, applications for registration, goodwill or copyrights in Market Distributing or its successors, legal representatives, and assigns in the U.S without additional consideration, but at the expense of Market Distributing.

The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration of said mark shown in Exhibit A to said Market Distribution, Inc.

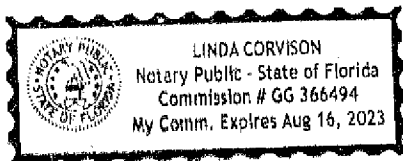

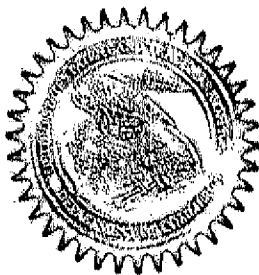
