RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made and effective as of January 5, 2021, by JPMORGAN CHASE BANK, N.A. (the "Bank"), in connection with that certain Pledge and Security Agreement, dated as of May 29, 2015 (the "Security Agreement"), executed in favor of the Bank by LOGIC GLOBAL, INC., a Delaware corporation, LOGIC INFORMATION SYSTEMS, INC., a Minnesota corporation (the "Assignor"), LOGIC INTERNATIONAL, INC., a Delaware corporation, LOGIC INTERNATIONAL HOLDINGS, LLC, a Delaware limited liability company, LOGIC MANAGEMENT SERVICES CORPORATION, a Delaware corporation, CASCADERA, INC., a Texas corporation, and YOMARI INFORMATION SERVICES INCORPORATED, a Minnesota corporation, and their respective successors, assigns and legal representatives.

WHEREAS, pursuant to the Security Agreement, Bank and Assignor executed a certain confirmatory Notice of Grant of Security interest in trademarks, dated as of May 29, 2015 (the "Confirmatory Agreement") (together with the Security Agreement, the "Security Agreements");

WHEREAS, the Confirmatory Agreement was recorded with the United States Patent and Trademark Office as No. 900326710, at Reel 005545, Frame 0514 on June 04, 2015;

WHEREAS, the parties desire to confirm the release of all security interests Bank may have in the IP Collateral (as defined below) pursuant to the Security Agreements; and

WHEREAS, Assignor has requested that Bank enter into this Release in order to effectuate, evidence and record the release and reassignment to Assignor of any and all right, title and interest Bank may have in the IP Collateral (as defined below) pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby states as follows:

1. **Release of Security Interest.** Bank, and its successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements, in any and all right, title and interest of the Assignor, and reassigns to the Assignor any and all right, title and interest that it may have, in, to and under the following (collectively, the "IP Collateral"):
 - (a) Any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source in which Bank has been granted a security interest under the Security Agreements, including the trademark registrations identified in Schedule I hereto, together with the goodwill connected with the use thereof and symbolized thereby;
 - (b) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(c) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Further Assurances.** Bank agrees to take all further actions, and provide to the Assignor and its successors, assigns and legal representatives all such cooperation and assistance with respect to releasing the IP Collateral, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Assignor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
