TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is between **Clarkwestern Dietrich Building Systems LLC** (the "Assignor") and **Illinois Tool Works Inc.**, a Delaware corporation, with a place of business at 155 Harlem Avenue, Glenview, Illinois 60025 (the "Assignee").

WHEREAS, Assignor is the owner of fifty percent (50%) right, title, and interest in the trademark TRUSSTEEL, including United States Registration No. 2,414,992 (the "Trademark"), by virtue of letter agreement dated May 16, 2005, between Dietrich Industries, Inc. (as successor in interest to Unimast Inc.) and Alpine Engineered Products, Inc., in which Alpine Engineered Products, Inc. acknowledged that Unimast Inc. is the joint owner of the Trademark;

WHEREAS, Unimast Inc. assigned its interest in the Trademark to Dietrich Industries, Inc., which assigned its interest to Assignor; and

WHEREAS, Assignor desires to assign its right, title, and interest in and to the Trademark to Assignee and Assignee desires to acquire Assignor's right, title and interest in the Trademark, together with the goodwill of the business in connection with which the Trademark is used.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, assign, and transfer to Assignee all of Assignor's right, title, and interest in and to the Trademark, together with the goodwill of the business associated with the Trademark and United States Registration No. 2,414,992, and any proceeds and claims relating to past, present, and future infringement of the Trademark.

At Assignee's expense, Assignor will reasonably assist in obtaining or providing any further documents that may be required to confirm chain of title thereof.
