## PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Partial Release") is made effective as of December 31, 2020 (the "Effective Date") by U.S. BANK NATIONAL ASSOCIATION, in its capacity as collateral agent (in such capacity, the "Notes Collateral Agent") under that certain Indenture dated August 4, 2020 (as amended, restated, supplemented, or otherwise modified from time to time, the "Indenture") by and among FORUM ENERGY TECHNOLOGIES, INC., a Delaware corporation ("FET"), FORUM US, INC., a Delaware corporation ("Forum US"), and the guarantors party thereto, and U.S. Bank National Association, as trustee and Notes Collateral Agent. Capitalized terms used herein but not otherwise defined shall have the meanings given to them in the Trademark Security Agreement (defined below).

WHEREAS, in order to induce U.S. Bank National Association, as trustee and Notes Collateral Agent to enter into the Indenture, and the Holders (as defined in the Indenture) to purchase the Notes (as defined in the Indenture), FET, Forum US and the other grantors party thereto executed and delivered to Notes Collateral Agent that certain Security Agreement, dated as of August 4, 2020 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, FET, Forum US, the other grantors party thereto and the Notes Collateral Agent executed and delivered to Notes Collateral Agent that certain Trademark Security Agreement dated August 4, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement"), whereby the grantors party thereto agreed to grant to the Notes Collateral Agent a security interest in all of their respective Trademark Collateral, including, without limitation, the Trademark Collateral of Forum US listed on Schedule I attached hereto and made apart hereof;

WHEREAS, Forum US, as seller, has entered into that certain Asset Purchase Agreement dated as of December 31, 2020 (the "Purchase Agreement") with Anvil International, LLC, a Delaware limited liability company, as buyer (the "Buyer"), and solely for the limited purposes set forth therein, FET, pursuant to which Forum US has agreed to sell to Buyer certain properties and assets relating to the ABZ® and Quadrant® brands as described in Section 1.01 of the Purchase Agreement (the "Assets"); and

WHEREAS, in connection with the sale of the Assets pursuant to the Purchase Agreement, Forum US will be transferring certain Trademark Collateral listed on Schedule I attached hereto and made apart hereof (collectively, the "Released Collateral") and has requested that the Notes Collateral Agent release all of its right, title and interest in and to such Released Collateral.

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:


RELEASE. The Notes Collateral Agent hereby fully, immediately, and irrevocably releases and discharges and by these presents does hereby fully, immediately, and

irrevocably release and discharge the security interests created by the Trademark Security Agreement and the Security Agreement solely in and to the Released Collateral (and no other Trademark Collateral) upon assignment or other transfer of the Released Collateral to the Buyer pursuant to the Purchase Agreement. All other rights, titles, and interests of the Notes Collateral Agent in the Trademark Collateral which are not assigned or otherwise transferred pursuant to the Purchase Agreement are unaffected by this Partial Release.
