TRADEMARK SECURITY AGREEMENT
(New Loan Distribution)

THIS TRADEMARK SECURITY AGREEMENT, dated as of January 25, 2021, is made by Dean & DeLuca, Inc. ("D&D Inc."), Dean & DeLuca Brands, Inc. ("D&D Brands"), Dean & DeLuca International, LLC ("D&D International"), Dean & DeLuca Small Format, LLC ("D&D XP"), Old DDUS, Inc., formerly known as Dean & DeLuca New York, Inc. ("Old DDUS"), Dean & DeLuca Atlanta, LLC ("D&D Atlanta") and Dean & DeLuca Markets, LLC ("D&D Markets", together with D&D Inc., D&D Brands, D&D International, D&D XP, Old DDUS and D&D Atlanta, the "Grantors" and each a "Grantor"), in favor of The Siam Commercial Bank Public Company Limited (the "Bank").

WITNESSETH:

WHEREAS, on March 31, 2020, the Grantors, as debtors and debtors-in-possession (in such capacity, "Debtors"), filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code with the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court"), which cases were jointly administered under Case Number 20-10916 (MEW) (each a "Chapter 11 Case" and collectively, the "Chapter 11 Cases");

WHEREAS, on November 20, 2020, the Debtors filed their Fifth Modified Proposed Joint Chapter 11 Plan of Reorganization [Doc 433] (as subsequently revised or otherwise modified, the "Chapter 11 Plan");

WHEREAS, on November 25, 2020, the Bankruptcy Court entered the Findings of Fact, Conclusions of Law and Order Confirming Debtors' Plan of Reorganization [Doc 445] (the "Confirmation Order"), which Confirmation Order, *inter alia*, authorized and approved the reorganized Debtors' entry into a secured credit agreement (as it may be amended, amended and restated, novated, supplemented or otherwise modified from time to time, the "Secured Credit Agreement") for maintaining and continuing of a senior secured term loan facility in the aggregate principal amount of \$779,629.16 with the Bank on account of the Bank's secured claim in respect of the prepetition Bank Loan (as defined in the Chapter 11 Plan);

WHEREAS, pursuant to the Secured Credit Agreement, each Grantor has agreed to grant to the Bank a security interest and lien upon all of the assets of each Grantor, including, all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired trademarks, trade names, service marks, business names (including internet domain names) and brands, including registrations and applications therefor (collectively, "Trademarks"), together with the goodwill of the business associated with such Trademarks, and all products and proceeds thereof, to secure the payment and performance of the Obligations (as defined in the Secured Credit Agreement) of the Grantors under the Secured Credit Agreement; and

WHEREAS, each Grantor is a party to the Secured Credit Agreement pursuant to which such Grantor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Bank to enter into the Secured Credit Agreement and to induce the Bank to maintain and continue the term loan thereunder, each Grantor hereby agrees with the Bank as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Secured Credit Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Secured Credit Agreement) of such Grantor, hereby mortgages, pledges and hypothecates to the Bank, and grants to the Bank, a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral to the extent of such Grantor's interest (the "Trademark Collateral");

(a) all of such Grantor's Trademarks and all intellectual property licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to in Schedule I hereto;

(b) all modifications, variations, renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and liabilities at any time due or payable to or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

Section 3. Security. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Bank pursuant to the Secured Credit Agreement and each Grantor hereby acknowledges and agrees that the rights and remedies of the Bank with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Secured Credit Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. This Trademark Security Agreement shall be deemed a Collateral Document (as defined in the Secured Credit Agreement).

Section 4. Grantors Remain Liable. The Grantors hereby agree that, anything herein to the contrary notwithstanding, the Grantors shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with their Trademarks and intellectual property licenses subject to a security interest hereunder.

Section 5. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts,

each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart. Delivery of an executed counterpart of this Trademark Security Agreement by facsimile or a scanned copy by electronic mail shall be equally as effective as delivery of an original executed counterpart of this Trademark Security Agreement.

Section 6. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
