**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**WHEREAS** Prophix Software Inc., a corporation incorporated in the Province of Ontario (the “**Debtor**”), is or was the owner of the trademarks (as well as the underlying goodwill of such trademarks) and patents listed in Schedule “A” (collectively, the “**IP**”);

**AND WHEREAS** Canadian Imperial Bank of Commerce (“**CIBC**”) entered into a general security agreement and trademark and patent security agreements with the Debtor whereby the Debtor agreed to grant to CIBC a security interest in the IP and other certain property;


**AND WHEREAS** a notice of security interest was filed against the IP with the Canadian Intellectual Property Office (“**CIPO**”) and the United States Patent and Trademark Office (“**USPTO**”);

**AND WHEREAS** on or about February 1 2021, the indebtedness of the Debtor to CIBC was indefeasibly repaid in full by the Debtor;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CIBC hereby (i) releases and discharges its security interest in the IP; and (ii) irrevocably authorizes and directs Chaitons LLP to take all steps necessary and make all required filings with CIPO and USPTO to effect such release and discharge.
