RELEASE OF SECURITY INTEREST

This Release of Security Interest is entered into as of February 4, 2021, by and between COMERICA BANK ("Bank") and DATICA, INC., a Delaware corporation (f/k/a Sansoro Health, Inc.) ("Grantor").

RECITALS

A. Bank and Grantor are parties to an Intellectual Property Security Agreement, dated as of November 27, 2018 (the "IPSA") pursuant to which Grantor granted and pledged to Bank a security interest in all of Grantor's right, title and interest in, to and under its Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C thereto). The IPSA was recorded on November 28, 2018 on Reel/Frame: 047597/0366 and 6489/0292.

B. Bank has agreed to release its security interest in the Intellectual Property Collateral.

AGREEMENT

Now therefore, Bank agrees that it terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral.

Delivery of an executed signature page of this release by electronic transmission shall be as effective as delivery of a manually executed counterpart hereof. Bank acknowledges that this release along with any other necessary documentation may be filed with the USPTO or any other governmental office to evidence the termination granted herein. Bank authorizes the Grantor and its designees to record this release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of Bank's security interest in the Intellectual Property Collateral.
