**RELEASE OF SECOND LIEN GRANT OF  
SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made effective as of February 10, 2021, by and from MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent (in such capacity, the “Collateral Agent”) to WEB.COM GROUP, INC., a Delaware corporation (“Web”), and LOCAL ONLINE, LLC, a Delaware limited liability company (“Local” and, together with Web, each, a “Grantor” and collectively, the “Grantors”). All terms not herein defined have the meanings set forth in the Security Agreement or the applicable Trademark Security Agreement referenced below.

WHEREAS, the Collateral Agent and the Grantors entered into that certain Second Lien Security Agreement, dated as of October 11, 2018, by the Grantors party thereto in favor of the Collateral Agent (together with all amendments, supplements and modifications, if any, from time to time made thereto, the “Security Agreement”);

WHEREAS, the Collateral Agent and the Grantors party thereto entered into the Second Lien Grants of Security Interest in Trademarks as specified on Exhibit A (each, a “Trademark Security Agreement”), pursuant to which the Grantors party thereto granted a security interest to Agent in, among other things, all of the Grantors’ right, title and interest in, to and under the Collateral (as defined below), including the Trademarks set forth on Exhibits B and C hereto; and


WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Trademarks set forth on Exhibits B and C and reassign the same without recourse to the Grantors;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases its lien and security interest in all of each Grantor’s right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Exhibits B and C hereto), including the goodwill associated therewith and the right to receive all Proceeds therefrom (the “Collateral”), and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to the applicable Grantor.
