Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned limited liability company executed the following Certificate of Merger:

**FIRST:** The current name of the surviving company is Sococo, LLC, a Delaware limited liability company ("Surviving LLC"), and the current name of the corporation being merged into the Surviving LLC is Prysm, Inc., a Delaware for-profit corporation ("Merging Corporation").
