Pursuant to Section 14-11-906 of the Georgia Limited Liability Company Act (the "Act"), the undersigned limited liability company does hereby submit this Certificate of Conversion for the purpose of converting to a foreign corporation.

1. The name of the limited liability company is The Relevant Group, LLC.
2. The name of the resulting entity will be Greenwood, Inc. and the jurisdiction to which the limited liability company shall be converted is the State of Delaware.
