**CONFIRMATION OF TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This CONFIRMATION OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Termination and Release"), dated as of February 26, 2021, from JPMorgan Chase Bank, as Administrative Agent (the "Administrative Agent"), to Tenneco Automotive Operating Company Inc., a Delaware corporation (the "Grantor").

**WITNESSETH:**

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of November 4, 1999, made by Tenneco Automotive Inc., Tenneco Automotive Operating Company Inc., Tenneco International Holding Corp., Tenneco Global Holdings Inc., The Pullman Company, TMC Texas Inc. and Clevite Industries Inc. (together with any other entity that may become a party as provided therein), in favor of JPMorgan Chase Bank, as Administrative Agent (as amended from time to time, the "Collateral Agreement"), Grantor pledged and granted to the Administrative Agent, for the ratable benefit of the Lenders to secure the satisfactory performance and payment of all Obligations of the Grantor, a continuing security interest (the "Security Interest") in the Trademarks, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Security Interest in United States Trademarks dated as of July 28, 2003, among the Administrative Agent and Grantor (the "Security Agreement"), Grantor, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Administrative Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 17, 2003 at Reel 2825 and Frame 0494.

WHEREAS, the Administrative Agent terminated and released the entirety of its Security Interest in all collateral, including the Trademark Collateral, pursuant to the Pay-off Letter, dated as of October 1, 2018 (the "Pay-Off Letter")

WHEREAS, the Administrative Agent now desires to confirm its termination and release of the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided or provided by reference in the Collateral Agreement and the

Security Agreement. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings provided or provided by reference in the Collateral Agreement and the Security Agreement.

2. Release of Security Interest. The Administrative Agent hereby confirms, without recourse, representation or warranty of any kind whatsoever, that the Pay-Off Letter terminated the Security Agreement and terminated, released and discharged its Security Interest in and to the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral thereby became null and void. Notwithstanding the foregoing, to the extent it is deemed that the Pay-Off Letter did not effect such termination, release and discharge, with this Termination and Release the Administrative Agent hereby, without recourse, representation or warranty of any kind whatsoever, terminates, releases and discharges its Security Interest in the Trademark Collateral, including, without limitation, the Trademarks referred to on Schedule A hereto.

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully effectuate the release of the Security Interest contemplated hereby.
