ASSIGNMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Secured Party absolutely and unconditionally assigns any and all right, pursuant to the Security Agreement, to the Trademarks to the Grantor. Secured Party absolutely and unconditionally terminates, cancels, discharges and releases any and all security interests it has against the Trademarks pursuant to the Security Agreement or otherwise.

Secured Party shall take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

Secured Party expressly acknowledges and affirms that upon execution hereof, it shall have no rights and remedies with respect to the Trademarks.
