## TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST (this "Release") is made as of March 2, 2021 in favor of Hallcrest, Inc., an Illinois corporation ("Grantor"), by JPMorgan Chase Bank, N.A., as successor in interest to American National Bank and Trust Company of Chicago, as Agent for the Lenders ("Lender").

WHEREAS, in an agreement executed on or about December 16, 1997 (the "Security Agreement"), Grantor granted to American National Bank and Trust Company of Chicago, as Agent for the Lenders (as such term is defined in the Security Agreement) a security interest in Grantor's right, title and interest in and to intellectual property, including in and to the trademark registrations set forth on Schedule 1 attached hereto (collectively, the "Intellectual Property");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 24, 1997 at Reel/Frame 1667/0901; and

WHEREAS, Lender wishes to release its security interest in the Intellectual Property and assign to Grantor all of Lender's right, title and interest in and to the Intellectual Property of Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Lender hereby terminates the Security Agreement, terminates, cancels and releases any security interest it may have under the Security Agreement including in the Intellectual Property, and assigns to Grantor any rights it may have under the Security Agreement including in the Intellectual Property.

Lender shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release. Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
