TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made this 8th day of February, 2021 (the “Release Date”), by MANUFACTURERS AND TRADERS TRUST COMPANY, as administrative agent for the Lender Parties (as defined in the Guarantee and Security Agreement referred to below) (in such capacity, the “Agent”), for the benefit of each of RV RETAILER TEXAS, LLC, a Texas limited liability company (“RV Texas”), RV RETAILER TEXAS II, LLC, a Texas limited liability company (“RV Texas II”) and RV RETAILER EAST, LLC, a Florida limited liability company (“RV East”, and together with RV Texas and RV Texas II, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, (i) the Grantors have entered into that certain Guarantee and Collateral Agreement, dated as of November 2, 2018, in favor of the Agent (the “Guarantee and Collateral Agreement”), (ii) RV Texas entered into that certain Grant of Security Interest in Trademarks, dated as of November 2, 2018, in favor of the Agent (the “RV Texas Trademark Security Agreement”), (iii) RV Texas II entered into that certain Grant of Security Interest in Trademarks, dated as of November 2, 2018 (the “RV Texas II Trademark Security Agreement”), and (iv) RV East entered into that certain Grant of Security Interest in Trademarks, dated as of December 7, 2018 (the “RV East Trademark Security Agreement”, and together with the RV Texas Trademark Security Agreement and the RV Texas II Trademark Security Agreement, collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the Trademark Security Agreements, each Grantor pledged and granted to the Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the following Collateral of such Grantor, whether then existing or thereafter arising or acquired from time to time: (i) all of such Grantor’s Trademarks set forth on Schedule I hereto (collectively, the “Trademark Collateral”), (ii) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement) of the Trademark Collateral, and (iii) all IP-Related Rights (as such term is defined in the Guarantee and Collateral Agreement) of the Trademark Collateral;

WHEREAS, the Agent has filed with the United States Patent and Trademark Office (the “USPTO”) notices of security interests in the Trademark Collateral, (i) the RV Texas Trademark Security Agreement was recorded by the USPTO on November 5, 2018 at Reel 6475, Frame 0812, (ii) the RV Texas II Trademark Security Agreement was recorded by the USPTO on November 7, 2018 at Reel 6477, Frame 0525, and (iii) the RV East Trademark Security Agreement was recorded by the USPTO on February 11, 2019 at Reel 6556, Frame 0712;

WHEREAS, the obligations of the Grantors to the Agent have been paid in full and the Grantors have requested that the Agent release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Agent hereby, without any representation and warranty and without any recourse (a) terminates the Liens and security interests created under each Trademark Security Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral, and (d) terminates each Trademark Security Agreement except for any provisions therein that expressly survive termination.

2. Recordation of Release. The Agent understands and agrees that this Release may be recorded by or for each Grantor with the USPTO.

3. Further Actions. The Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release; provided, that all such documents are to be prepared by counsel to such Grantor and the cost and expense of such documents and actions shall be borne solely by such Grantor.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Guarantee and Collateral Agreement and the Trademark Security Agreement, as applicable.
