**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “**Release**”) is granted on this 16th day of March, 2021, by Antares Capital LP (“**Antares**”), as administrative agent under the security agreement referenced below, in favor of Hygiena LLC (“**Hygiena**”), with respect to the Trademarks (as defined below).

W I T N E S S E T H :

WHEREAS, on August 26, 2016, Antares and Hygiena entered into a Trademark Security Agreement, which was recorded with the U.S. Patent and Trademark Office (the “**USPTO**”) on August 26, 2016, at Reel/Frame 5864/0098 (the “**2016 Trademark Security Agreement**”);

WHEREAS, pursuant to the 2016 Trademark Security Agreement, Antares received a security interest in all of Hygiena’s right, title and interest in, to and under the United States trademarks and trademark applications listed on Schedule I attached hereto, including all proceeds and products thereof (hereinafter all of the foregoing trademarks, applications for trademark registrations and all proceeds and products thereof, collectively, the “**Trademarks**”); and

WHEREAS, Antares desires to release any and all security interests, and any other lien, it has in the Trademarks, and assign all right, title and interest it may have in and to the Trademarks to Hygiena.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Antares hereby agrees as follows:


1. Antares hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges each security interest in the Trademarks that was granted to Antares under the 2016 Trademark Security Agreement, and any and all other security interests or liens that Antares or its predecessors, successors and assigns may have in or to the Trademarks under the 2016 Trademark Security Agreement.
2. Antares acknowledges and agrees that the 2016 Trademark Security Agreement has been terminated.
3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks. Antares agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release.

4. This Release shall be governed by and construed in accordance with the law of the State of New York.
5. This Release shall be binding upon Antares' representatives, successors, assigns and transferees.
