PARTIAL TRADEMARK ASSIGNMENT

This Partial Trademark Assignment (“**Assignment**”), effective as of March 12, 2021, is entered into between Cask 3, Inc., a Delaware corporation with a business address at 520 Broadway, 4th Floor, New York, NY, 10012 (“**Assignor**”), and TTO IP, LLC, a Delaware limited liability company with a business address at 520 Broadway, 4th Floor, New York, NY, 10012 (“**Assignee**,” and together with Company, the “**Parties**”, and each, a “**Party**”).

WHEREAS, Assignor is the owner of the United States trademark TEN TO ONE, along with the corresponding United States Registration No. 5,875,881 (collectively, the “**Mark**”);

WHEREAS, Assignor wishes to partially assign the Mark to Assignee, such that Assignor and Assignee become joint owners of the Mark with equal interests therein, and Assignee wishes to acquire such rights;

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Partial Assignment. Assignor hereby assigns to Assignee partial right, title and interest in and to the Mark equivalent to fifty percent (50%) of Assignor’s interest therein, together with commensurate portions of the goodwill of the business connected with the use of and symbolized by the Mark, and the right to sue and recover for past infringement of the Mark.
2. Joint Trademark Ownership. As of the Effective Date, the Parties shall be considered joint owners of the Mark, each Party with an equal interest therein.


