## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of March 25, 2021 (this "Release") is made by Comerica Bank, as Agent (the "Secured Party"), under the Agreement (Trademark) dated as of November 1, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Secured Party, United Laboratories Manufacturing, LLC, a Delaware limited liability company and INW Manufacturing, LLC, a Delaware limited liability company (f/k/a United Manufacturing Holdings, LLC) (together, the "Debtors") and recorded on November 7, 2017 in the records of the United States Patent and Trademark Office at Trademark Reel 6198, Frame 0725.

Pursuant to the Security Agreement, the Debtors granted to the Secured Party a security interest ("Security Interest") in the Debtors' trademark collateral, including but not limited to the trademarks listed on attached Exhibit A (the "Released Trademarks").

The Secured Party now wishes to terminate the Security Agreement and release and terminate the Security Interest in the Released Trademarks.

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

1. The Secured Party hereby irrevocably terminates the Security Agreement and irrevocably discharges, releases and terminates the Security Interest in the Released Trademarks.

2. The Secured Party hereby assigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, any and all of Secured Party's right, title and interest in and to the Released Trademarks granted to and/or obtained by it pursuant to the Security Agreement.

3. The Secured Party authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable governmental authority record this Release.


This Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of Texas.
