**PARTIAL TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Partial Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of March 30, 2021, by **BARCLAYS BANK PLC** (“Common Collateral Agent”) in favor of **DONLEN CORPORATION**, an Illinois corporation with an address at 2135 Sanders Road, Northbrook, Illinois 60062 (the “Released Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

W I T N E S S E T H:

WHEREAS, the Released Grantor, together with certain other Grantors, entered into a certain Trademark Security Agreement dated May 6, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) with Common Collateral Agent, notice of which was recorded on May 6, 2020 at the United States Patent and Trademark Office at Reel 6931, Frame 0427;

WHEREAS, the Released Grantor granted Common Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of Common Collateral Agent, in all Trademark Collateral of the Released Grantor, including without limitation the Trademarks listed in **Schedule A** (collectively, the “Released Trademark Collateral”); and

WHEREAS, the Common Collateral Agent has agreed to terminate and release the Security Interest in all such Released Trademark Collateral as herein provided, and this Trademark Release is applicable only with respect to the Released Trademark Collateral, which is owned by the Released Grantor, and not to any other Trademark Collateral owned by the other Grantors party to the Trademark Security Agreement (the “Remaining Trademark Collateral”).

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Common Collateral Agent hereby releases, terminates and discharges the Security Interest and any and all of its interest in the Released Trademark Collateral, and reassigns, transfers and conveys to the Released Grantor any right, title or interest it may have in such Released Trademark Collateral, without recourse to the Common Collateral Agent, and without representation or warranty of any kind. The Common Collateral Agent retains its security interest in the Remaining Trademark Collateral.
