**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of March 31, 2021 (the "Effective Date"), is made by **THE TORONTO-DOMINION BANK**, a Canada corporation (the "Lender"), in favor of **KLICK INC.**, a Canada corporation with an address at 175 Bloor Street East, North Tower, Third Floor, Toronto, Canada M4W3R8 (the "Canadian Borrower"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Lender entered into that certain Confirmation of Security Interest in Intellectual Property dated as of May 30, 2019, with the Canadian Borrower, notice of which was recorded by the United States Patent and Trademark Office on June 3, 2019 at Reel 6659, Frame 0571 and Reel 49343, Frame 0592, and by the United States Copyright Office on December 28, 2015 at Volume 9932, Document 459 (the "Intellectual Property Security Agreement");

WHEREAS, the Canadian Borrower granted the Lender, under the terms of the Intellectual Security Agreement and Security Documents, a security interest (the "Security Interest") in favor of the Lender, in and to all of its Intellectual Property, including the Trademarks, Patents and Copyrights listed in Schedule I and the underlying goodwill of the foregoing (collectively, the "Intellectual Property Collateral").


WHEREAS, the Lender has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender hereby releases, terminates and discharges any and all of its interest in the Intellectual Property Collateral of the Canadian Borrower, and assigns, transfers and conveys to the Canadian Borrower any interest in such intellectual property, including the Security Interest.
