RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of April 1, 2021 (this “Release”), is made by ANTARES CAPITAL LP, as Administrative Agent (the “Administrative Agent”), in favor of Worldwide Facilities, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meaning given to them in the Security Agreement.

WITNESSETH

WHEREAS, Grantor and the Administrative Agent, and the other parties from time to time party thereto, are parties to that certain Pledge and Security Agreement, dated as of September 5, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Trademark Security Agreement, dated as of September 5, 2019 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on September 5, 2019 at Reel/Frame No. 6737/0318, pursuant to which the Grantor granted to the Administrative Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in, all right, title or interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantor has requested that the Administrative Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
