FOURTH: The Plan of Conversion relating to the foregoing has been approved in accordance with all applicable statutes.

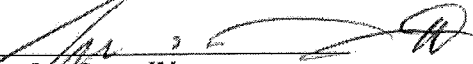

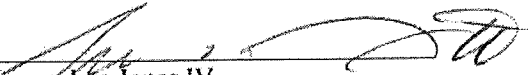

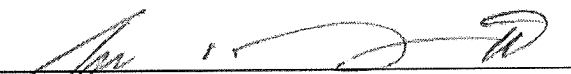
